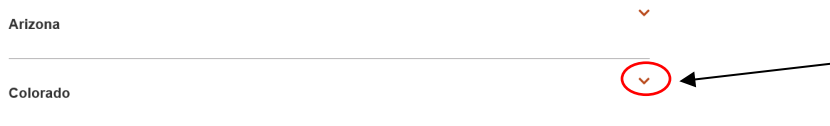


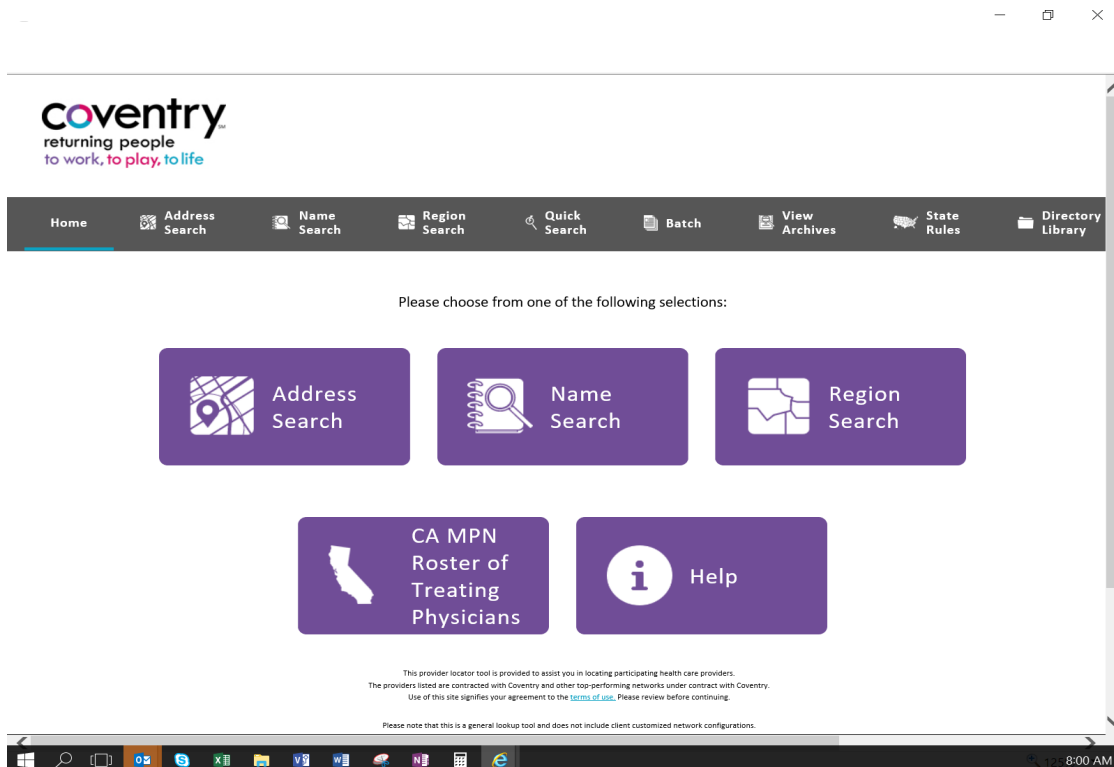
TalisPoint Quick Reference Guide

How to Complete a Work Site Poster for a Panel through TalisPoint.

1. From the main CopperPoint website, <https://www.copperpoint.com>, hover over Claims & Incidents and when the drop down appears, click on 'Find A Medical Provider'. This takes you to 'Find A Workers' Compensation Healthcare Provider'. Click on the carrot to the right of the state in which you are looking for a provider in.



2. Based on the state selected you will find different options to find a provider. If looking for providers in Colorado or Nevada, you will be directed to Coventry's TalisPoint site by clicking on the web address provided on the screen. After clicking the link, you will see the following page:

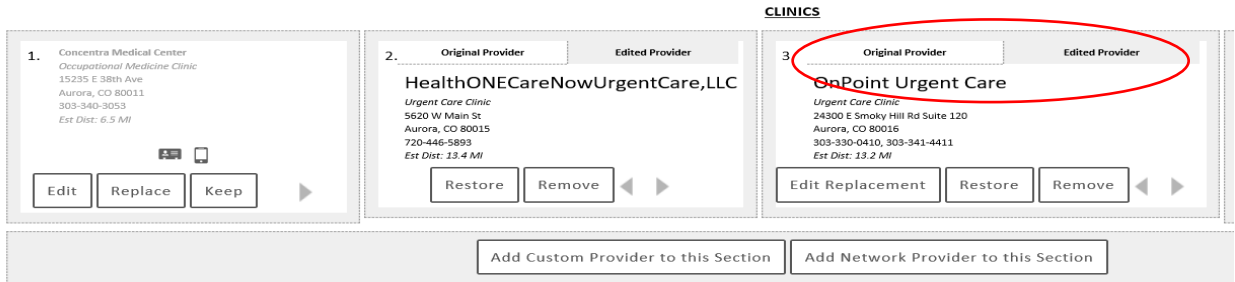

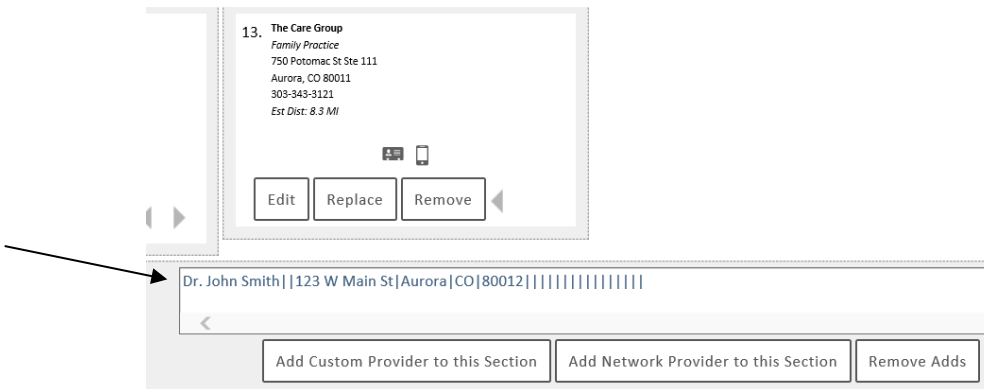

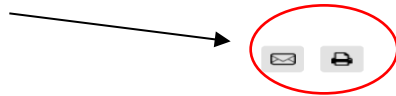
